



## Francesco Colombo Memorial 5th,6th,7th,8th September 2024

### QUEEN TROPHY 2024 REGULATIONS

#### **Art. 1**

Motoclub Pepe BEVAGNA Registered Office in via Orvieto 13 – 06039 Trevi (PG), Administrative Office in via Salvo d'acquisto 6 – 06031 Bevagna (PG) is the Organizer of the 7th Edition of the Queen Trophy, an *Adventouring Tourism* Event registered in the FMI National Calendar on September 6<sup>th</sup>, 7<sup>th</sup>, and 8<sup>th</sup> 2024.

#### **Art. 2**

The Event, which is nationwide and non-competitive – in compliance with the *ADVENTOURING TOURISM* Regulations –, is characterized by a taste for adventure. It is a Touristic-Cultural Event that offers participants the opportunity of discovering places, villages, and people uncontaminated by mass tourism, but are the keepers of our people's traditions.

The itinerary develops on roads open to public traffic, approximately 30% of which are asphalted roads and 70% back and dirt roads; it is divided into three legs for a total of about 600km. All participants are required to strictly comply with the Highway Code.

The Organizer will supply participants with track directions - GPS track or other format at the request of participants -, general information in writing.

The supplied itineraries have been communicated and authorized by the competent authorities for the Territory, participants are to follow these indications.

The given mileage may be subject to variations (increasing or decreasing) due to unforeseen causes or forced deviations.

#### **Art. 3**

Motorcycles allowed: Non-specialist motorbikes, weighing no less than 150 kg. Only approved knobby tires are allowed.

In case of bikes weighing less than 150 kg, only the following categories may participate:

- Women
- Riders over 65
- Bikes over 25 years old

Vehicles must be strictly in compliance with the Highway Code Regulations. Those riders who need to change the registered bike, are required to notify the BEVAGNA Pepe Bevagna Moto Club no later than 01/09/2024. Failure to comply with these rules will result in immediate expulsion. No refund nor compensation shall be due in case of expulsion.

#### **Art. 4**

For safety purposes, it is mandatory to wear technical clothing, including boots, protections, and a helmet in compliance with the law provisions. Moreover, motorbikes have to be equipped with knobby tires. Failure to comply with any of the above will lead to exclusion from the event, without any right to fee refund.

#### **Art. 5**

Anyone in possession of a valid motorcycle driving license and of an FMI (the sponsor of the event) membership card are allowed to participate to the event, irrespectively of their citizenship or nationality. The FMI membership card may be requested from any of the Moto Clubs in Italy or directly from the Pepe Bevagna Moto Club at a fee of € 55.00.

#### **Art.6**

The itinerary may be followed via GPS track - or other formats upon request --. Leg size will be a maximum of 9,900 points, and legs can be loaded on all GPS and / or on all smartphones. The organizers will also provide a list of the towns and places to be crossed, the itinerary variants to shorten the route, as well as reference points.

#### **Art.7**

Checking on registrations, papers, and motorcycles, as well as the relevant documentation delivery will be carried out on Thursday 5<sup>th</sup> September 2024 from 14:30 to 19:30 and Friday 6<sup>th</sup> September 2024 from 07:30 to 08:30 in BEVAGNA (PG). Who it will be not registered at 8:30 of friday the 6<sup>th</sup> of September will be excluded by the event.

#### **Art. 8**

##### **DEPARTURE:**

Friday at 09:30 a.m. from Bevagna once enrollment and baggage delivery completed.

Saturday at 05:30 a.m. from Fabriano after baggage delivery (05:00).

Sunday at 08:00 a.m. from Passignano sul Trasimeno after baggage delivery.

ANY WITHDRAWING participant is under the OBLIGATION to notify the **Queen Trophy Organization** at the supplied Emergency Number or at the staff at the Departure area of his/her withdrawal before 07:30 a.m. or 05:00 a.m. of the respective departure day.

The Organisation reserves the right to suspend, cancel or modify departure time and/or date in case of force majeure.

**Art. 9**

All participants will be given a control table where all passages will be ticked during the event. Check points will be set along the entire track to verify the transit of riders and provide information and help. ALL participants are required to stop and have their control table stamped. We advise to consult the roadmap and overall schedule to work out the right cruising speed.

Riders are requested to proceed with their group so as to help each other in case of need.

The expected average speed has been calculated for a fun and safe ride, offering you time to take pictures and stop and relax if you so wish.

In case of inclement weather, running speed should be adjusted according to road practicability.

We RECOMMEND to follow WET tracks.

**Art. 10**

GPS tracks will be supplied in the course of the days preceding the event, according to the communicated times and modalities. Participants are required to load the tracks on their GPS system prior to the Queen Trophy departure.

**Art. 11**

A team of doctors and specialised personnel – following participants either bike-riding or driving in a Jeep – will be at the disposal of participants. However only first aid operations and non-specialist medical and mechanical assistance may be guaranteed. In case of more serious events, emergency numbers will be called, while in case of serious mechanical failures, a rescue vehicle will be called, transportation costs will be at participants' account.

**Art. 12**

The Organization will offer baggage service upon request. Upon enrollment, you will be given a card where to write your name and address to apply to your luggage. The Organization shall not be held responsible for the contents of the baggage nor for its loss in case the identification card is not properly secured.

**Art. 13**

The registration fee is indicated in "Participation Options" and includes all items therein described, including the FMI event insurance.

The registration fee does not include: mandatory FMI membership fee, overnight accommodation, petrol, vehicle rescue costs, and anything else not expressly included.

**Art. 14**

Maximum number of participants: **150**. The Organization reserves the right to exceed this limit at its sole discretion.

**Art. 15**

In case of proven justified impediment, the participant will be entitled to a refund equal to 50% of the enrollment fee, SUBJECT to sending a written notice to via registered mail or PEC e-mail before 26th August 2024 to the following address:

No refund shall be claimable in case of notice received after 26th August 2024.

Any eventual refund will be paid within 30 days from the end of the event.

Nothing will be refund of the deposit (150€) in any case.

**Art. 16**

In case the event is cancelled due to force majeure, no enrollment fee shall be reimbursed.

**Art. 16 Bis**

Were the event to be cancelled due to COVID 19 Government Dispositions, the paid enrollment fee will be considered valid for the 2025 Queen Trophy.

**Art. 17**

Failure to comply with the hereinafter regulations will result in the Immediate Disqualification of the Rider:

- Queen Trophy Regulations;
- Highway Code;
- Non-compliant clothing, non-knobby tires, lack of spare parts, etc. as indicated in Art. 4;
- Skipping the briefing meeting, unless promptly notified and due to serious impediment; Reckless driving which could endanger other riders and/or third parties.

**Art. 18**

Any dispute arising out of or in connection with the participation to this Queen Trophy, any dispute arising out of or in connection with these Regulations, including, but not limited to any issue regarding their enforceability, and interpretation shall be exclusively referred to and finally resolved by the Event Resolution Commission (CDE).

The Organization reserves the right to modify these Regulations by giving notice – by means of numbered and dated newsletters, and/or press releases, and/or Web – as it may deem appropriate. Such amendments shall be deemed as an integral part of these Regulations.

**Art. 19**

**Enrollment Refusal:** The Organization reserves the right, at its sole discretion, to refuse/withdraw

registration to those participants who are deemed unsuitable/incompatible to participate in the Queen Trophy 2024.

**Art. 20**

**Image Rights:** by registering to the Queen Trophy, each participant TACITALLY AUTHORIZES the Motoclub Pepe Bevagna to the publication and dissemination of his/her image in order to create videos/DVDs for reporting or journalistic purposes. Furthermore, he gives mandate and authorization to professionals of the sector to carry out video/photographic sessions.

**Art. 21**

By registering to the Event, Riders implicitly agree they have read and understood these Regulations - which discipline the event – in their entirety and undertake to comply with them. Furthermore, Riders agree to release the Organizing Committee, the Sponsoring Bodies and any other Physical Entity, with no exception, from any and all liability arising from damage to people or property as a result of their participation in this event, including the travel to and from their home place to the meeting places. By registering to the event, participants waive their rights to refer to the Court of Law or any other such Body. These Regulations may be subject to updates which will be eventually communicated during preliminary operations.

IN CASE OF A DISPUTE, THE ITALIAN VERSION SHALL PREVAIL
