Liability Waiver

I hereby undertake to:

5. to take full liability in case the signatory chooses not to follow the itinerary indicated by the organiser, for which choice he/she shall be deemed solely responsible;
6. to have read, understood, and accepted the Event Regulations, as well as having read the Personal Data Information pursuant to Regulation (EU) 2016/679. The undersigned grant the Organizers, Officers on Duty, Sponsors, and any other Individual who has cooperated in any way with the Organization, full exemption from any liability pertaining to any physical injury or material damage he/she may incur during the event, as well as from any liability arising from any physical injury or material damage he/she may be individually or jointly responsible for. The undersigned expressly declares to accept for any compensation due for any reason whatsoever the terms, conditions, and maximum compensation amounts as defined by the Insurance Policy available at www.federmoto.it. The undersigned agrees that no claim may be brought to the Court of Law, but any controversy arising from this event shall be exclusively referred to the Sports Justice.

To understand that the disrespect of such regulations might lead to harmful situations.
